The refuge serves primarily as a nesting, feeding, resting and staging areas for migratory waterfowl. The varied habitats support approximately 266 species of birds, 42 species of mammals, plus rep-

tiles, fish, amphibians and insects. Bald eagles have maintained an active nest on the refuge since 1986. Management goals also address the needs of species of special concern including black tern, black ducks, osprey, American woodcock, and peregrine falcons which use the refuge during some time of the year. This will be a great family and guest event, the trails are well groomed for easy walking. Bring a bagged lunch, your cameras and binoculars! Details and directions in the spring newsletter.



Book Review: Deerland by Al Cambronne

Many New York forest owners embark down that path looking for a place to hunt deer. Al Cambronne's <u>Deerland</u> (©2013 Lyons Press, \$18.95, \$13.74 on Amazon) provides a thought-provoking examination of the role of whitetail deer in American society and the tangled relationships between and among deer, man, and the environment which should appeal to both deer hunters and forest owners alike.

Deerland's lofty subtitle "America's Hunt for Ecological Balance and the Essence of Wildness" belies its highly accessible nature. Although scholarly researched, the 244-page book relies more extensively on interviews, anecdotes, and examples to illustrate the complexity of the deer-man relationship simultaneously in conflict and symbiotic, never in complete balance. Cambronne starts out explaining why and how the biology of the whitetail deer has allowed it to evolve into the highly adaptive and prolific organism it is (a true case of survival of the fittest). Through the use of vivid phrases as clever as they are on occasion provocative (for example, he labels the big-business reality of deer hunting as the "deer-industrial complex" which produces a "cash crop"), Cambronne examines deer hunting culture and traditions before delving into the positive impacts of deer and deer hunting on local economies (such as sporting goods stores, outfitters, restaurants, hotels, and even real estate markets). He also, of course, examines the negative impacts of deer, and especially of deer overpopulation: deercar collisions (branding deer the "deadliest animal in North America"), over-browsing of forests, decimation of agricultural crops, and destruction of residential shrubbery (the "invasion of the suburban cervids"). He also discusses the importance of venison as a food source, especially in rural and lowincome communities (the "other red meat" he calls it), as well as the ravages of disease (both on deer, such as CWD, and deer-spread, such as Lyme dis-

Cambronne also thoughtfully dissects the many challenges of deer management (scientific, social, and political), and explains how deer management is just as much about human management and the accommodation of the competing interests and views of diverse and often conflicting stakeholders (including hunters, who he reports State wildlife professionals deride as "barstool biologists"). Cambronne discusses the folly of birth control, bait-and -shoot, and controlled suburban hunts as costeffective or realistic means by which to address



deer overpopulation on any meaningful scale, thus leaving deer hunters as the most effective weapon in the game biologist's arsenal. In the process, he examines the various methods by which hunters are deployed as deer managers (such as antler restrictions, doe permits, and earn-a-buck programs), all as preceded by an account of deer numbers from near-extinction at the turn of the 20th century to a near (and, in some areas, actual) nuisance today; included is an interesting psychanalysis of the largely, but not entirely, historical aversion to the harvesting of does.

In the end, Cambronne offers no solutions or conclusions, apparently resigned to the seeming futility of ever bringing man, nature, and society into perfect harmony. But if actually answering such questions is not what Cambronne set out to do, he has at least succeeded in providing a comprehensive framework within which to intelligently ask them. Despite its sometimes intentionally provocative turns of phrase, <u>Deerland</u> presents a fair-minded and even-handed portrayal of deer and deer hunting in and on the American landscape; its many insights will no doubt provide food for thought to any forest-owning deer hunter.

My Turtle Story by Deb Bandinelli

We've known for years that we have painted or box turtles in our pond. The turtles range in size from about the size of a silver dollar to almost 10". We love to watch them sun themselves on our "turtle tree"; it fell in the pond in 1998 and we just left the top in the water.

In June I was mowing the grass near the pond and watched as a turtle was digging in the dirt with her back legs. I stopped to watch and then continued to mow. The Mother turtle stayed and remained digging a small hole. I don't know how long she stayed there, but the mower didn't scare

We found one dead baby that didn't fully develop. He continued digging, finding 3 brand new baby turtles! Joe took each baby down to the pond and washed some of the hardened dirt off. The babies seemed to come to life! Joe then placed the babies on the shore near the water's edge. Nicholas sat near the babies and after about 30 minutes he excitedly came running "Miss Debbie-the baby turtles

crawled into the water and swam off!" His excitement was contagious!

I'm glad we unearthed the baby turtles; I think between the clay soil and dry summer, the babies had a hard time finding their way out of their hole.
