



A Message From the Chairman...

A handful more cases of Oak Wilt Disease were reported in NYS, such was also outlined and discussed in SAC's last Newsletter. According to Joe, earlier this year, the Canadian government planned to impose a quarantine on any species of Oak log being imported from NYS to Canada, between May 1, 2018 and October 1, 2018. This would be a real problem for NY log producers, land owners, and of course the Canadian saw mills. The saw mills joined together, and convinced the government to repeal the quarantine. As a result, the government came up with a set of stringent rules and regulations to follow. For the time being, Oak log exports to Canada can continue, for this year anyway.

Things will be different in 2019.

At the risk of sounding repetitive, market conditions have been very good, with high demand and high prices. There are currently no species of hardwoods that would be considered a "dog". Even the lumber markets have been doing extremely well. With kiln dried lumber demand high, and warehouse inventories low, sawmills are cranking away. The only complaint is the shortage of logs at the mills. Log exports to other countries, especially China, are under fire because of this.

Coincidently, China is now reinforcing the law that all logs must be debarked or fumigated before shipping to Mainland China, and now requiring the same for all logs being shipped from Hong Kong to the Mainland. As a result, all shipments to China and Hong Kong have currently stopped. This has put a damper on our industry as well as the Chinese sawmills. There are meetings being held right now, that we hope, will help to resolve these issues.

I'll have an update for you all by our Annual Picnic in July. Hope to see you there!

From Committee Member, Gerry McDonald: My son Tom always gets me thoughtful Christmas gifts. This year, he got me a newfangled chainsaw sharpener made by Stihl. At first glance, I

was skeptical. It has a lot going on. There are 4 guide bars, 2 round files, 1 flat file, and skewed ends for holding everything in place. After trying it, I am **sold**. This is the best saw chain sharpening invention ever! This contraption sharpens the teeth and files the rakers to the correct height all in one pass. After securing the saw bar in a vise, you only need 4, or maybe 5 passes for each tooth. The end housings are oriented at the correct file angle, and you just need to keep the file level and apply some pressure. I couldn't find the name of the device, but I did find a good instructional video at https://youtu.be/SzjmpNTVH6U



If you want to save time, and get results, this is well worth it.

NYFOA CDC Sponsored Spruceton Valley Maple Syrup Tour...

On March 24, 2018, Jason and I attended, and represented NYFOA, at the Spruceton Valley Maple Syrup Tour. Located on Spruceton Road in West Kill, owners Skip and Lori Dippold gave us a thorough and interesting tour of their sugar house, and showed us all the hard work that goes into the daily operations. We learned that it takes four Maple trees, at least 40 years old, to yield enough sap in six weeks, to produce just one gallon of syrup. Forty gallons of sap have to be

boiled down in the huge stainless steel evaporator. Skip has over 3300 taps, averaging 800

gallons of Organic syrup a year. A lot of hard work, and commitment is required of the whole Dippold family, to man the fire, operate the evaporator, and sterilize, filter, grade, and pack each gallon of this delicious syrup.

An assortment of tasty Maple treats were available for purchase, along with their infamous Organic Maple Syrups. As tokens of appreciation, our handcrafted wooden NYFOA magnets were given to owners, Skip and Lori Dippold, and the other attendees.
