Directions

Our meeting location is about 7 minutes north of Ochiota, NY on N. Branch Rd. When a woods walk does not have a physical address, we strongly recommend you become familiar with the target area via google maps, your GPS or smart phone app. Enter **N Branch Rd, Vermontville, NY**! Most apps recognize this entry!

Meeting area is in the vicinity of where the road changes names to Cold brook road (Old Military Rd or Hunters Camp Rd on some maps) Note - Some maps will show two turns for N. Branch Rds about 500 feet part off of Kushaqua-Mud Pond Rd. The southernmost turn is the primary but either should work.

Travelling from the North: Take Kushaqua-Mud Pond Rd south out of the loon Lake area. Approximately 5 miles after leaving the Loon Lake turn right on to N Branch Rd and travel about I mile to meeting point.

Travelling from the South: Enter Ochiota NY on route 60. Route 60 turns in to Kushaqua-Mud Pond Rd just as you enter Ochiota. Continue straight through Ochiota and <u>do not turn right and follow route 60</u>. Shortly after exiting Ochiota, N Branch Rd will be on the left as Kushaqua-Mud Pond Rd curves to the right.

LAFCO is also active in managing private forestland in the region, purchasing standing timber and purchasing delivered logs on the open market at our log yard in Chestertown NY.

Successful Woodlot Management for Song Birds Woods Walk Summary

The Northern Adirondack Chapter jointly sponsored and conducted a woods walk with New York Audubon on September 15 in the town of Westport in Essex County. The Southern Adirondack and The Southern Tier Chapters also conducted similar workshops through last summer. NY Audubon has partnered with NYFOA to provide support and financial reimbursement for this state-wide series of public woods walks on the topic of forest management to provide songbird habitat. Another series of workshops will be conducted this summer hosted by The Lower Hudson and Allegheny Foothills Chapters. Visit the Audubon website https://ny.audubon.org/conservation/woods-wildlife-and-warblers to learn more about the project and bird management.

The Westport workshop was held on the town's 1200-ac watershed which has been actively managed for forest products for the past 60 years. The 35 participants toured 2 recently harvested sites. Daniel Beheide with the Essex Co. Soil & Water Conservation District was the chief forester and explained the objectives and techniques of the harvests. Zack Boerman with NY Audubon explained the positive impact of the harvest on songbirds that require early successional stage forests. Gary Goff, NAC chair, provided many forest and bird management publications and covered how to identify the 6 native maple species found in NY state. Gary has also established an Assessing Vegetation Impacts from Deer (AVID) demonstration area on the watershed. Please visit the website https://aviddeer.com/ to learn more about this important opportunity to contribute to monitoring the impact of deer on forest regeneration.

Audubon graciously provided a bag lunch and the attendees had a chance to collect publications and chat during the log landing lunch break. DryShod Boot Company provided a gift certificate that we raffled off. The 35 participants represented 13 forest ownerships and who owned/managed an average of 175 acres.

Note: The first two webinars will be led by Dr. Alexandra Kosiba, Climate Forester from the Vermont Department of Forests, Parks & Recreation. The fourth will be presentations from forest carbon project developers. Charles Levesque, executive director of the North East State Foresters Association and Coordinator of the Securing Northeast Forest Carbon Program effort, will moderate the webinars.

A Nesting Box That Yields Results

Anyone who has spent time providing wildlife nesting boxes knows results are not always rewarded despite patience and attention to all the build requirements. Bat houses in our experience, have yielded the best results. Provide a large enough structure to moderate temperature, include baffles ³/₄" to 1" max apart, and mount high to yield a clear flight out and you will have bats. Any nest box building while not complicated has number of key parameters that if followed can increase your results. These notes are just a starting point. We urge you to research further.

Location & Mounting:

- 1) Sunny side (6-8 hours) of your house or on a secondary structure
- 2) Select location where Bat guano can fall and accumulate away from humans
- 3) Best if location is relatively quiet and away from human activity
- 4) 16'+ Tall posts mounted securely into the ground normally with Quikrete or similar
- 5) Height is key. 10' from ground to entry at bottom of box is good 12-20' is better. Two person job.
- 6) Trees are really not an ideal option. We recommend you research best practices on this approach

General Nesting Box Materials Needed (specifics are plan dependent):

- 1) ½"+ Exterior grade plywood (NOT pressure treated) is ideal for insulating purposes
- 2) 3/4"-1" thick cedar or other rot resistant grade woods (Other wood may work but must be painted to last)
- 3) Roof Black asphalt or galvanized metal (brown flashing works fine)
- 4) Exterior grade nails and/or screws
- 5) Exterior water based (latex) paint and caulk
- 6) Paint color should be dark brown or black for houses mounted within NAC territory

Box Styles:

- 1) Single Chamber house With just one room may not it provide enough mass to moderate temperatures
- 2) Multi Chamber House 2-4 chamber houses start to increase heat and bat holding capacity
- 3) Rocket Box A linear design usually from a cedar 4x4 attached to 12'+ pressure treated

- 2) Bat Conservation & Management https://batmanagement.com/ Extensive website providing details on every aspect of bat management. Quality full sized boxes sold. Mounting instructions and videos are very helpful.
- 3) Amazon or other retailers All of a sudden everyone is selling Bat houses! Be aware that a \$30-\$50 box is likely very light weight and smaller than you think (= less mass = less ability to moderate heat). Check and compare actual dimensions to other options! While mounting may be easier, you may have mixed results.
- 4) Some of the key design features to be considered are noted below the corresponding picture
