Ellenberg Woods Walk

NYFOA member and Master Forest Owner Volunteer, Bruce Bennett, hosted our spring woods walk on Saturday, May 13. It was a beautiful spring day (pre-black fly) as 21 interested forest owners, and foresters and educators toured Bruce's property. Bruce's primary ownership goal is the creation and maintenance of wildlife habitat, with an emphasis on early-successional game species such as ruffed grouse and woodcock. He has wisely sought out both technical and financial assistance from private and government organizations. Tricia LaValley, acting Conservationist for the NRCS covering Franklin, Clinton, and Essex Counties joined us to explain some of the programs available to private landowners. Todd Waldron (Forest Conservation Northeast Director with the Ruffed Grouse Society was present to tell us how Bruce used some of the advice provided by that organization. Kristin Ballou, District Forester with Franklin County Soil & Water Conservation District also joined us and explained the benefits of enrollment in the USDA Environmental Quality Incentives Program (EQIP). Bruce is also enrolled in the NYS Forest Tax Law program, 480-a, administered by NYS Dept. of Env. Conservation.

After introductions in Bruce's barn/tool garage, we headed out to walk some access roads and see and discuss some of the results of his habitat management work. It was all very impressive! Song birds were singing and ruffed grouse were drumming. There were lots of questions from the attending forest owners regarding the timing of harvests, planting efforts and role of the various programs Bruce is enrolled in. Bruce fortunately is not plagued with exotic invasive plants and deer overpopulation as many forest owners remarked. Biologists and foresters along with the group commented on the importance of tree and shrub species diversity. For example, there was a very large and healthy high-bush cranberry shrub.

We all came back to the garage and greatly enjoyed a grilled lunch served up by Bruce and his wife Debra. There was ample opportunity to chat amongst the attendees and pick up the many good handouts provided by Cooperative Extension and NYFOA. Steve Sherwood, DEC Forester from Region 6, explained the many programs and services offered by NYSDEC.

After lunch we went down the road to a new piece of property Bruce acquired that he will be managing for maple syrup production. It appeared to be the perfect hard maple stand that just needs some thinning and time to mature. Bruce definitely has an eye for wise investments and management goals! Thank you, Bruce, for hosting the woods walk and showing us how to get it done right, very impressive!

NAC's next woods walk will be this fall at the SUNY ESF Wanakena Ranger School. Watch for further announcements. The NAC woods walk committee of Scott Bonno, Bob Coupal, Bill Lynch and Steve Sherwood are due a pat on the back for the great work of planning and delivering the series of woods walks we have had over the past few years!!! Greetings to all NYFOA members,

"Every day I step outside the door of my Ontario County home and into the forest south of Honeoye. This is my home in the Bristol Hills; the forest here extends into Hi Tor and Urbana and far beyond and is my place of refuge and recreation, the source of firewood and shelter from the summer heat and driving snow, the place my children grew up and found their love of the outdoors, and where we walk our dogs and ride our horses.

Recently I had the privilege of sweeping the first ten miles of the inaugural Great Hill Ultra trail run, a 100-kilometer race through the forests and hills around Naples NY. It's a slow pace, running up and down these hills, about three hours and 1,500' elevation gain for ten miles following the last runner in the pack, ensuring the course is clear after that first section of the race. But what an opportunity to spend time on the trail surrounded by trees and all their glory, winding in and out, up and down; and having time to really reflect on how truly essential our forests are - and in this time of land being gobbled up for so many uses, the health of our forests is not an accident, but a result of careful planning and care. I want you to know that I am joining this organization, the New York Forest Owner's Association as an administrator, but also as a fellow lover of our forest spaces; I crave the wave-like sound of wind in the trees on winter evenings, the music of frogs and birds that mark the breaking of spring, the wave of cool shade in the summer, and the distinctive crunch and smell of leaves on the forest floor as fall leads into winter.

Before I had kids and taught English at Finger Lakes Community College, Penn Yan Middle School, and Naples High School so I could be on my kids' schedule, I spent ten years working as an administrator at the Greater Rochester Metro Chamber of Commerce and a small but mighty IT firm called The Rochester Group, Inc. I was blessed with many opportunities in those roles and had experiences as an HR assistant, billing administrator, the program director for the Chamber's corporate training program, manager for a DOD program assisting small businesses gain government contracts, writing grant applications, and organizing logistics for Chamber member events.

I am thrilled to have been selected for this position and am looking forward to supporting you, our members, and staff, as you care for, and develop each of your parts of our great forests here in New York. I'm looking forward to meeting you soon."
