Directions to the Grange:

From the South:

I-87 North to Exit 31, Essex Ferry and Westport. At the end of the ramp, turn Right and make an immediate Left (follow signs for Ferry). Go up the hill past the Hilltop Motel and continue to a T junction. At the stop sign turn right (you are now in Wadhams!). At the next stop sign, turn Left onto Route 22, going north. Follow Route 22 approx. 6 miles to Whallonsburg. The Grange is on the right at the corner of Route 22 and Whallons Bay Road.

From the North and from Essex Ferry:

I-87 to Exit 33 Willsboro/Essex Ferry/Route 22. Turn left at the end of the ramp onto Route 22 South. Follow Route 22 about 8 miles into the town of Willsboro. Stay on Rt. 22 as it goes down a hill and crosses the Boquet River. Continue on Route 22 through Willsboro and up a hill. Go past the Village Market and continue on Route 22 (also called Lakeshore Road) another 5 miles to the Village of Essex. You will go past the ESSEX FERRY DOCK to the stop sign. Turn Right, continuing on Route 22. Follow this another 5 miles or so to Whallonsburg. The Grange is on the left at the corner of Route 22 and Whallons Bay Road.

Walk Level of Difficulty:

The first 3 stops will be on terrain with less than 15% slopes. We will be:

- 1) Walking on skid trails
- 2) Just off the road and on an old landing (header). We will make a suitable path through any blackberries.
- 3) CATS trail with a 2.5 chain (how many feet?) side trip to a permanent inventory plot.
- 4) Old skid trails and rocky trails with a 600 foot elevation gain.

A Window on Tomorrow's Forests

The 20 states that make up the northern U.S. constitute the most heavily forested and most densely populated quadrant of the Nation. Whether your interest is in natural resources or energy, the economy or urban planning, how these forests change over the course of the next 50 years matters. The forests of tomorrow will be rooted in what we do, or do not do, today.

The Northern Forest Futures Project gives forest owners, managers, and other decision makers information to guide sustainable management of the 174 million acres of public and private forests in the northern U.S.. Past and current changes that are positive include: reduced exploitive logging, more sustainable timber harvesting, increased wild fire suppression, and an increase of millions of acres of forestland as a result of abandoned marginal farmland. But current and future changes that are of great concern include: expanding impact of invasive species, loss of species diversity, low diversity in forest age classes, increasing urban expansion that is shrinking forest acreage, fragmentation of forest land, parcellation of forest ownerships, loss of forest-based employment, effects of burgeoning white-tailed deer populations on tree regeneration and forest composition, and increasing atmospheric carbon emissions.

The challenges facing northern forests are large, complicated, intertwined, and enduring. All forest owners (public and private), natural resources agencies and organizations (e.g. NYFOA) and all citizens have a role to play in curbing these trends. An abbreviated listing provided by the report includes:

- Strengthen people's connection to rural and urban forests
- Develop mutually beneficial partnerships among forest owners, managers, industry and society to support conservation goals
- Develop measurable state and regional goals for forest diversity and monitor progress toward achieving them
- Promote forward-looking forest management across all ownerships
- Estimate the types and number of forestry jobs that can be sustainably supported, now and in the future
- Work to understand the many dimensions of forest change

Bullock Woods Walk

Do you know all you need to know to successfully grow trees? Join woodland owner and research collaborator Herb Bullock, along with Cornell's State Extension Forester Peter Smallidge, on September 24, 2016 from 9:00 to noon at Herb's property in the Town of Edwards. St. Lawrence County for a woodland tour.

Hosted by Herb, the tour will focus on what it takes to plant, establish and grow trees in the face of damage from deer browsing, as well as other related forest regeneration concerns. Herb has worked for a number of years planting and protecting tree seedlings from deer, including the use of tubes and other measures to limit browsing. He has also worked to manage interfering plants such as ferns and other shrubs.

In 2015, Cornell University Cooperative Extension began investigating the effectiveness of low-cost fencing to exclude deer, and also to develop a simple field survey that uses plants as indicators of the severity of deer browsing. The woods walk will look at these efforts to grow trees, demonstrate methods for assessing deer impact, and tour other projects that Herb has already completed. Numbered tags will be provided to woodland owners who want to monitor deer impacts. The terrain is gentle and the trail will cover a mile or less. UTV transport is available.

Grilled lunch provided after the walk.

Personnel will be available to discuss the NY Forest Owners Association, the NYSDEC resources and assistance with private woodland management, and Cornell's Master Forest Owner volunteer program.
