Upcoming Southern Tier Chapter Meetings and Programs:

April 22: Bluestone Quarry Tour:

It is common knowledge among forest owners that the most valuable black cherry in the world comes from the southern tier of New York and the northern tier of Pennsylvania. But did you know that all of the bluestone in the world is quarried within a 90-mile radius of Deposit, NY? Several of our members have been approached about prospecting for bluestone deposits on their properties and have expressed an interest in learning more about how a quarrying operation might fit in with their overall forest management plans.

The Mirch Family, owners of Tompkins Bluestone in Hancock, have invited us to tour their facilities and a nearby quarry on Saturday, April 22nd. We will learn how they prospect for stone deposits, cut and remove stone from the quarry, and restore the site when the quarry is closed. Current regulations governing quarry operations and typical royalties and contracts with landowners will also be covered. We will also tour the Tompkins stone finishing operations, including an awesome computerized, 10-foot diameter diamond saw. After leaving the Tompkins stone yard and processing facility, we will visit a nearby operating quarry and a quarry that has been closed and restored.

We will assemble at 7:45 a.m. in the rear parking lot at Cornell Cooperative Extension, 840 Front Street, Binghamton. We will organize and travel to Hancock in car pools as much as possible, and will depart promptly at 8:00 a.m. Four wheel drive SUV's and extended cab pickups appreciated since the road to the quarry can be rough. We plan to be finished by noon, and be back to CCE by 1:00. Tour will take place regardless of weather. Tour is free, but pre-registration is required Call Kevin Mathers at CCE (772-8954, x130) or Jerry Michael (648-2941).

Directions to Tompkins Bluestone Co.:

Drive East (from Binghamton) on Route 17 and exit at Fish's Eddy Exit, about five miles East from Hancock. Turn right at the end of the exit ramp and drive west on Old Route 17 for about 2 miles. Turn right on the bridge over Main Route 17. After crossing the bridge, turn right and drive about ¼ mile on Tar Hollow Road. Tompkins Bluestone will be on your left.

June 17: Tree ID, Measurement, and Value If you would like to be able to identify the trees on your property, learn how to measure the volume of wood in a tree, and learn about some of the factors that determine the value of timber, this workshop is for you. The tree ID portion of this program will be conducted at nearby Wolfe Park in the Town of Chenango. Prior to visiting the park, Gerry Kachmor, DEC Forester, will explain how trees are measured to estimate their volume, and discuss factors that determine the economic value of timber. The workshop starts at 9 a.m. and ends at approximately 11 a.m., and will be held at Cornell University Cooperative Extension of Broome County, 840 Upper Front Street, Binghamton (just north of exit 5 from interstate 81). The program is free, but registration is required, please call (607) 772-8954 to register.

Other News:

The tree tax has been the big hub-but lately What this you ask? Well...it turns out that there has been a method on the books of the Office of Real Property Service in Albany, a method for assessors to collect more money based on the value of your standing timber on your land. Well this "tax" has been around for a very long time, long ago when most of us weren't concerned about our trees because they had more aesthetic value than dollar value. But that has been carried along and now some town assessors are basing the value of your property on the additional value of your standing timber. Some landowners have seen their property taxes quadruple because of this In an age when we can hardly manage to pay the highest taxes in the nation on our forested lands, where do they think we'll get the money to pay them four times higher? Several things come to mind really guick...one, the fast solution will be to clear cut. You can't tax something that isn't there. This will be devastating to our forested lands. The second thing that comes to mind is, our trees are inventory. Not one single entity in NYS other than forest owners are being taxed on their inventory. Farmers are not taxed on standing crops! Warehouses are not taxed on their goods stored there! Imagine the far reaching consequences!!! Hey, lets start taxing the jewelers down in the Manhattan diamond district on their inventory and we'll see how fast things change!

Anyhow, its time YOU got off your backside and let your feelings known! Senator Young has proposed legislation (S. 6818) and Assemblyman Parment has a similar bill in the Assembly (A. 6638) that would exclude the value of our trees for the purposes of real property tax assessments. WRITE, EMAIL or CALL EVERYONE YOU KNOW to support this legislation. I for one see two options here if we don't take action NOW...chainsaw or for sale sign.

Organization Spotlight:

Empire State Forest Products Association - ESFPA

In 1906, the Adirondack Lumber Manufacturers and Shippers Association was formed to help track declining inventories of Adirondack softwood and promote the emerging science of forestry. Three years later the name was changed to the Empire State Forest Products Association to reflect the addition of new members from other regions of the state and a growing statewide interest. Today the Association enjoys a diverse and growing membership. Membership stands at over 400 businesses and individuals and is growing. Members include forest landowners, timber harvesters, furniture companies, lumber manufacturers, pulp and paper companies, and other wood product manufacturers from across New York state. Members own and manage 1.2 million acres of New York forests and employ over one-third of the 65,000 individuals employed in the forest products industry in New York state.

ESFPA is a member of the Council of Forest Resources Organizations, along with NYFOA and currently hosts the Forestry Awareness Day in Albany (along with NYFOA and several other organizations). Under the "In Case You Don't Know Who to Call" Heading:

The DEC puts out a short pamphlet listing the consulting foresters who've signed up with the NYS Consulting Forester Program. This booklet is available free by contacting your regional DEC Forestry Office. In Region 7 its Cortland (607) 753-3095, Kirkwood (607) 775-2545 and Sherburne (607) 674-4036. In Region 4 its Stamford (607) 652-7365...other regions are accessible by calling the DEC Central Office at (518) 402-9425.

Additionally Master Forest Owners (MFOs) are available for free woods walks on your land and offer advice on many things involved with your forest. MFOs are volunteers who have undergone training and many times are woodland owners themselves.

The goal of the MFO/COVERTS Program is to provide private, nonindustrial forest owners with the information and encouragement necessary to manage their forests to enhance ownership satisfaction. MFOs do not perform management activities nor give professional advice. Rather, they meet with forest owners to listen to their concerns and questions, and offer advice as to sources of assistance based on their training and personal experience. The success of this volunteer program is grounded in the power of "peer" counseling. Knowledgeable and experienced forest owner neighbors can interact as unbiased peers with less-experienced forest owners. There are over 200 active volunteers across NYS who annually interact directly with hundreds of neighbors and indirectly with thousands through various outreach activities, such as newspaper articles, educational workshops and work with youth groups. These informed and dedicated volunteers are a great resource in their communities to assist other organizations and agencies in promoting the wise use of forest resources. Additionally, there is a call for folks who would like to become MFOs. Mr Gary Goff at Cornell would like to ask your help in nominating and soliciting candidates for the 2006 NY Master Forest Owner/COVERTS Volunteer Program. This year we will be conducting 2, new volunteer training workshops:

1. June 7 - 11, at Camp Shankitunk, Delhi, NY Applications due by May 22, 2006

2. Sept. 13 – 17, at Cornell University's Arnot Teaching and Research Forest VanEtten, NY (south of Ithaca in Schuyler Co.) Applications due by Aug. 28, 2006

Workshops run from Wed. evening to Sun. noon.

Volunteers (MFOs) can attend either workshop depending on convenience of their schedule and travel considerations. Volunteers can commute daily, or accommodations are available free at both sites. There is a \$50 fee for attendance of the 4-day training. Both workshops combine classroom and outdoor field experiences on a wide variety of subjects including; tree identification, finding boundaries, forest ecology, sawtimber economics, wildlife and sawtimber management, communication techniques, and a visit to a nearby sawmill.
